On Behalf half of the Board of Directors, we hope that everyone had a wonderful Easter, Mother's Day, Derby day and are getting ready for a fantastic summer.

The Homeowner's Association dues period has concluded. We would like to thank everyone who paid their dues on time. The Board understands and acknowledges that things happen and occasionally residents are late with their dues. Recently our treasurer was challenged by a resident who questioned the validity of the late fee and stated that it should be included in the deed restrictions, also known as the CCRs. Upon further research it was found that late charges and grace periods are controlled by the state of Kentucky. Kentucky has no minimum or maximum amount tor the late fees and no grace periods are required.

Our Homeowners Association at one time did only charge interest on unpaid dues to the maximum allowed usury rate of Kentucky. It was found that calculating this way was compounding interest which is not allowed. Results of this and the fact that calculating that way was laborious a decision by the Board was made to charge a flat late fee, which totalled nearly the same but with less effort.

Our HOA allows approximately a 45-day grace period. According to the CCR HOA dues are actually due every year by the first of the year none-withstanding the grace period allowed. We appreciate everyone planning this into their home budgets annually. Hope everyone has a great summer!
